Section 13: Article I, Section 14, Subsection E of the SGA By-Laws, which is to be created, shall read: "Executive Orders may not reduce the powers or rights of the SGA Senate nor grant any powers or rights currently held by a Senator or the SGA Senate as a whole to the Executive Branch."

Section 14: This Bill shall take effect immediately upon passage by the Student Government Association, the welfare of the students requiring it


